INGREDIENTS: Deionized Water, Cetyl Alcohol, Stearyl Alcohol, Stearalkonium Chloride, Dimethyl Stearamine, Hydrolyzed Silk Amino Acids, Hydrolyzed Wheat Protein, Panthenol (Provitamin B5), Tocopherol (Vitamin E), Aloe Barbadosis (Aloe Vera) Leaf Juice, Chamomilla Recutita (Matricaria) Flower Extract (Chamomile), Castor Isostearate Succinate, Vegetable Glycerine, Lactic Acid, Phenoxyethanol and Caprylyl Glycol (Optiphen®).

4. First-Aid Measure
